A 30 DAY RULE WILL BE IN EFFECT . IT MUST BE A FLAT CHARTED LINE IN QUALIFYING TIME WITHOUT A BREAK WITHIN 30 DAYS.

ALL HORSES MUST HAVE A ONE YEAR NEGATIVE COGGINS ON FILE OR TURNED INTO THE RACE OFFICE PRIOR TO ENTERING INTO RACES AND QUALIFIERS. THIS INCLUDES SCHOOLERS AND OR TRAINING HORSES. ANYONE NOT HAVING CURRENT NEGATIVE COGGINS WILL BE OMITTED FROM THE DRAW
HORSES MUST BE ACCEPTED AND CLASSIFIED BEFORE ENTERING. NO HORSE MAY MOVE BETWEEN CLAIMERS AND CLASSIFIED RACES UNLESS APPROVED BY RACE SECRETARY PRIOR. Horses entered in an incorrect class may be thrown out of the box.

AFTER EACH DAY OF RACING THE CLASSIFICATION LISTS WILL BE UPDATED.
HORSES BEING ADDED TO YOUR ROSTER MUST BE SUBMITTED TO RACING OFFICE THURSDAYS BY 9 AM FOR APPROVAL ON MONDAYS. YOU MUST HAVE THE FORM ENTIRELY COMPLETED OR YOU MAY NOT ENTER TO RACE.
ALL MDOB CLASSES NOT FILLING (EXCEPT D'S) WILL REVERT TO AN OPEN CLASS WITH PREFERENCE TO MD HORSES THAT WERE INITIALLY ENTERED. UNLESS THEY ARE IN TO GO.

Everyone must be licensed by the MRC to enter the grounds and paddock, this includes qualifying and training days.

**** NO DOGS ALLOWED ON THE GROUNDS.**

Qualifying Times: PACE - 2:03 TROT 2:05 TWO SECOND ALLOWANCE FOR TWO YEAR OLDS, ONE SECOND ALLOWANCE FOR 3 YEAR OLDS, ONE SECOND ALLOWANCE FOR MAIDENS 4 YO AND YOUNGER.

Please note: As per contract agreement , 60% of the days races will be written to reflect Maryland owned or bred.

In the past five years, Ocean Downs has seen its premium for on track Driver/Trainer Accident Insurance rise 53%. This coverage is mandated for your safety and has been provided by Ocean Downs at no cost to you. In order to help defray these additional costs, Ocean Downs will be initiating a \$3.50 per horse fee for all horses programmed to race.

This fee will be deducted from the owners' winnings for that particular horse. Horses not earning a check for that start will have the \$3.50 debited to the owners' account. All accounts with an outstanding balance must be satisfied at the end of the race meet to maintain eligibility for future meets.

The Ocean Downs horsemen's bookkeeper will administer this fee. Any questions regarding its application should be directed to Peter Szymanski.

Any horses that have been approved and classified that race at any other track other than Ocean Downs WILL & MUST be approved and re-classified prior to entering.

ALL CLAIMS MUST BE MADE BY A CERTIFIED OR BANK CHECK + 6% SALES TAX.

A \$35.00 TRANSFER FEE BY SEPARATE CHECK OR CASH IS ALSO REQUIRED.
