QUALIFYING RACES - TRAINERS ARE RESPONSIBLE FOR THE ADMINISTRATION OF LASIX.**

ALL TRAINERS MUST HAVE A SIGNED RACING APPLICATION AND WAIVER RELEASE ON FILE IN THE RACING OFFICE PRIOR TO PARTICIPATING AT ROSECROFT.

ROSECROFT ENCOURAGES HORSEMEN TO UTILIZE THE USTA'S COMPUTERIZED ENTRY PROGRAM WHEN ENTERING THEIR HORSES TO RACE. THE USTA'S AUTOMATED DRAW PROGRAM WILL BE USED TO DETERMINE POST POSITIONS. POST POSITIONS ARE RANDOMLY GENERATED.

THE RACING SECRETARY MAY CLASSIFY HORSES BASED ON PERFORMANCE, EARNINGS, AND OR SEX. HORSES NOT MAKING EACH OF THEIR LAST 5 STARTS AT ROSECROFT WILL BE CLASSIFIED BY THE RACING SECRETARY, REGARDLESS OF THEIR EARNINGS IN THEIR LAST 5 STARTS. EVENTS THAT DO NOT FILL AS WRITTEN MAY BE CHANGED AT THE DISCRETION OF THE RACING SECRETARY. EVENTS MAY BE COMBINED,OR NOT USED AT ALL. PURSE CAPS DO NOT APPLY ON NW PM CONDITION RACES. HORSES MUST HAVE A MINIMUM OF 10 STARTS IN 2018 TO BE CONSIDERED FOR PER START CONDITIONS. HORSES WINNING A CONDITION RACE MAY BE REQUIRED TO JUMP ONE CLASS REGARDLESS OF PREVIOUS EARNINGS.

PM WINS ONLY COUNT AT EXTENDED PM MEETS.

SMOKING IS NOT ALLOWED IN THE PADDOCK.

SAFETY VESTS AND A PROPERLY FASTENED HELMET MUST BE WORN AT ALL TIMES WHILE ON THE TRACK.

HORSEMEN ARE URGED TO USE THE WHEELBARROWS AND MANURE BINS WHEN CLEANING OUT THEIR HORSE TRAILERS IN THE PADDOCK PARKING LOT.
